PLACEMENT COMMITTEE RA 10575

RESOLUTION NO. 004-2017

WHEREAS, the Placement Committee of RA 10575 convened on December 12, 2017 at the New Conference Room, Bucor Administration Building, NBP Reservation Muntinlupa City at about 11:00AM;

WHEREAS, to ensure an objective assessment in the placement of qualified incumbent civilian personnel to various positions at the Administration Group, the Committee, after thorough discussion and exchange of views has agreed to adopt the following criteria in the placement of incumbent Admin personnel:

I. EDUCATION - 35 points
II. ELIGIBILITTY - 35 points
III. LENGTH OF SERVICE - 30 points

WHEREAS, the Committee consensus as bases for each criteria shall be as follows:

WHEREAS, the above criteria shall be applied within the same professional class/discipline and further applied within the same functional grouping, provided further that seniority in the Salary Grade shall be given preference to the next higher position, provided finally that only the holders of Salary Grade 24 shall be qualified for Directorate position;

WHEREAS, in instances of tie in points, the following additional criteria shall be applied in order of priority: Entry in the service and Age.

WHEREAS, the Committee agreed to accommodate all civilian personnel who are willing to transfer to uniformed ranks only on Corrections Officer I (CO I) and Corrections Technical Officer I (CTO I) positions upon submission of letter of intent to the Human Resource Development Section. It was also agreed upon by the Committee to waive height and age of the personnel, subject to the condition that they will still undergo trainings as required for the position;



WHEREFORE, premises considered, the Committee RESOLVES as it is hereby RESOLVED to recommend to the Officer-In-Charge Bureau of Corrections the approval of the above Point System for Placement of incumbent Admin personnel to the Indicative Staffing Pattern (ISP), pursuant to Republic Act 10575.
